

## Official Rules – ScoreCard® Hot Summer Cool Prizes Promo

THE ONLY OBLIGATION TO WIN IS COMPLETING A NEW, VALID PROFILE INCLUDING VALID EMAIL ADDRESS ON [WWW.SCORECARDREWARDS.COM](http://WWW.SCORECARDREWARDS.COM). NO PURCHASE OR REDEMPTION IS NECESSARY TO ENTER OR WIN. A PURCHASE OR REDEMPTION WILL NOT INCREASE YOUR CHANCES OF WINNING; NON-PURCHASE/REDEMPTION ENTRIES AND PURCHASE/REDEMPTION ENTRIES HAVE AN EQUAL CHANCE OF WINNING.

1. Eligibility: The ScoreCard® Hot Summer Cool Prizes Promo (the “Sweepstakes”) is open to legal residents of the fifty (50) United States and the District of Columbia and Guam who are 18 years of age or older as of July 15, 2014, and who, from July 15, 2014 through August 15, 2014, are cardholders in good standing and enrolled in the ScoreCard program with one of the participating FIBA member financial institutions (“Participating Financial Institutions”). Employees of Sponsor (as hereafter defined), Administrator (as hereafter defined) and Participating Financial Institutions, and their parent companies, subsidiaries, affiliates, and advertising and promotions agencies, and their immediate families (spouse and parents, children and siblings, and their spouses), and individuals living in the same households of such employees are ineligible. Eligible Entrants that complete a new, valid profile including a valid email address on [WWW.SCORECARDREWARDS.COM](http://WWW.SCORECARDREWARDS.COM) with accounts in good standing during the Promotion Period will earn one (1) entry for the Entry Period in which the profile was submitted. This entry will be entered in a drawing to win one of two prizes in the Hot Summer Cool Prizes Promo. In the event of a dispute over the identity of an Entrant, the entry will be deemed as entered by the name of the primary cardholder listed on the card account on the date the entry was earned.
